VERIFIED PETITION FOR DAMAGES AND INJUNCTIVE RELIEF

COMES NOW ~~plaintiff, MILTON H. OHLSEN, III~~ ("Mr. Ohlsen or "Plaintiff"), by and through his undersigned counsel, and for his petition ("Petition") against defendants JOEL HOLLENBECK ("Defendant Hollenbeck") and PAUL MCELLIGOTT ("Defendant McElligott") hereby states as follows:

ALLEGATIONS COMMON TO ALL COUNTS

1. Mr. Ohlsen, nicknamed "Skip," is a resident of Saint Louis County, Missouri.
2. To the best of Plaintiff's knowledge and belief, Defendant Hollenbeck is a resident of Saint Louis County, Missouri.
3. To the best of Plaintiff's knowledge and belief, Defendant McElligott is a resident of Jefferson County, Missouri.
4. Mr. Ohlsen was a contractor for Global Management, a Nevada corporation formed in 2002 and operates as a consulting company.

5. Mr. Ohlsen is a Member of Genesis MMA, a Delaware LLC formed in 2007 and which operates as mixed martial arts company.
6. Defendant McElligott is the brother of Peter McElligott, a former subcontractor for Global Management.
7. To the best of Plaintiff's knowledge and belief, Defendant Hollenbeck is currently an employee of Check Point, a computer technology firm, and currently works from home.
8. To the best of Plaintiff's knowledge and belief, Defendant McElligott is currently a day-laborer.

COUNT I – LIBEL

(as to Defendant Hollenbeck)

9. Plaintiff re-alleges and incorporates herein by this reference Paragraphs 1 through 8 as though fully set forth herein.
10. On or about December 10, 2007, Defendant Hollenbeck first published a website claiming to be a “public service announcement about Skip Ohlsen.”
11. Defendant Hollenbeck has altered the webpage numerous times, adding new content and making new assertions concerning Mr. Ohlsen. A copy of the website's contents as of February 5, 2008 is attached as Exhibit 1 and incorporated herein by reference.
12. The website contains claims that Mr. Ohlsen is a “federally convicted felon for dealing drugs” and that he “forfeited drug money that he had in his possession.”
13. The website also contains claims that two of Mr. Ohlsen's former employees “were shafted by Skip Ohlsen when their payroll checks bounced.”
14. The website also claims “Skip had not paid all the taxes he claimed to have paid” and bases this assertion “on the paystubs withholdings for all employees payroll [sic].”
15. The website asserts “some out of state fighters were written checks that did not clear.”
16. The website also asserts that “the Federal Elections Commission is / was investigating Skip Ohlsen’s activities as a campaign consultant.”
17. Further, an altered picture of Mr. Ohlsen was posted with the label “armed and dangerous,” implying he is a fugitive.
18. Some of the headings to subpages of the main webpage are labeled “Felon Drug Dealer”, “Scam Artist & Con Man”, “Drug Money Forfeiture”, and “Assaulting Women”.
19. The assertions and labels quoted in Paragraphs 12 through 18 are false, being complete

- factual fabrications, or significant misrepresentations of facts.
20. In spite of claims at the bottom of each webpage that the information is “speculation, opinion or rumor,” the webpages link federal indictment summaries from PACER, filed court documents, and reference examination of “paystubs withholdings for all employees payroll [sic].” Factual misrepresentations or false statements, not opinions, accompany these documents.
 21. There is a sentence the bottom of the webpage that the information is “speculation, opinion or rumor” is not clearly visible as each webpage appears; however no disclaimer appears at the top of any page as a lead-in, or on any part that immediately appears when any of the pages is accessed.
 22. Several webpages on the website contain solicitations to “contact the author” with additional information concerning the allegations against Mr. Ohlsen, despite contradicting claims that the website contains only “speculation, opinion and rumor.”
 23. By combining the purported federal indictment summaries, ~~filed court documents and~~ references to examinations of “paystubs withholdings from all employees payroll [sic]” with factual misrepresentations or false statements, Defendant Hollenbeck shows a reckless disregard about whether his statements are true, and thus is acting with malice.
 24. Due to the publication of this website, Mr. Ohlsen has suffered loss of business contracts ~~and new business opportunities, and harm to his personal and professional reputation.~~ These damages total Two Hundred Fifty Thousand and 00/100 Dollars (\$250,000.00).
 25. Defendant Hollenbeck acted with malice, and such actions warrant punitive damages in the amount of One Million Dollars (\$1,000,000.00).

WHEREFORE, Mr. Ohlsen prays for judgment against Defendant Hollenbeck for the full amount of his aforementioned damages, the aforementioned punitive damages, for his attorney's fees, costs and for such other and further relief as this Court deems just and proper.

COUNT II - LIBEL

(as to Defendant Hollenbeck)

26. Plaintiff re-alleges and incorporates herein by reference Paragraphs 1 through 25 as though fully set forth herein.

27. On or about December 3, 2007, Defendant Hollenbeck sent a letter to Michelle Ohlsen, wife of Mr. Ohlsen stating false allegations concerning Mr. Ohlsen and Defendant Hollenbeck's ex-wife.
28. Such letter was sent to Michelle Ohlsen in an attempt to induce Michelle Ohlsen to file for divorce against Mr. Ohlsen or cause injury to Mr. Ohlsen and Michelle Ohlsen's marriage.
29. Due to the false allegations contained in the letter sent by Defendant Hollenbeck, Michelle Ohlsen filed for divorce from Mr. Ohlsen on December 11, 2007.
30. Mr. Ohlsen has suffered economic loss due to the filing of the divorce by Michelle Ohlsen, along with damage to his personal reputation. These damages total Two Hundred Fifty Thousand and 00/100 Dollars (\$250,000.00).
31. Defendant Hollenbeck acted with malice, and such actions warrant punitive damages in the amount of One Million Dollars (\$1,000,000.00).

COUNT III - LIBEL

(as to Defendant McElligott)

32. Plaintiff re-alleges and incorporates herein by reference Paragraphs 1 through 31 as though fully set forth herein.
33. ~~On or about October 8, 2007, Defendant McElligott, posting under the name of~~ "Kracker," published assertions on a MySpace forum that Mr. Ohlsen "does not pay his labor" and is "currently under investigation by the federal elections committee [sic]." He further asserts that Mr. Ohlsen "owed over 6k in labor," and the debt was "long overdue for services rendered." A copy of the post is attached as Exhibit 2 and is incorporated herein by reference.
34. In the October 8, 2007 post, Defendant McElligott also states that he "would like to advise fox sports as well as any potential fighters to steer clear of this con man, as he is going down."
35. On or about January 14, 2008, Defendant McElligott, once again posting on the MySpace forum under the name of "Kracker" posts a link to Mr. Hollenbeck's website, claiming the site as a resource for "facts about Milton 'Skip' Ohlsen." A copy of this post is attached as Exhibit 3 and incorporated herein by reference.

36. Defendant McElligott claims that Mr. Ohlsen “managed to alienate everyone who once believed in him by stealing their hard earned wages.”
37. The January 14, 2008 post makes several references to Mr. Ohlsen smoking crack, and being a “crackhead.” The post also asserts that Mr. Ohlsen was “arrested on 4 counts of trafficking narcotics in 1995 and plead guilty in 1998 to these charges.” Defendant McElligott claims that this assertion is “public information.”
38. The January 14 post also asserts that Mr. Ohlsen began a relationship with a “young 20 something year old [sic]” which resulted “in the young lady becoming hooked on crack”.
39. The January 14 post was later modified on or about January 20, 2008. A copy of this modification is attached as Exhibit 4 and incorporated herein by reference.
40. The modified post states that Mr. Ohlsen “petitioned the courts for an order of protection against me 1-16-08” and that Mr. Ohlsen “has not paid my brother.”
41. The January 20 post repeats false claims made on Defendant Hollenbeck’s website that Mr. Ohlsen gave fighters bad checks and not withholding payroll taxes.
42. The claims and assertions in “Kracker’s” posts as detailed in Paragraphs 33 through 41 are false, being a complete fabrication, or a significant misrepresentation of facts.
43. Defendant McElligott posted assertions substantially similar to Paragraphs 33 through 41 on the Fox Sports message boards, and various other mixed martial arts message boards. ~~Copies of these posts are attached as Exhibit 5 and incorporated herein by reference.~~
44. The January 20 MySpace forum post claims that its contents are “speculation and the opinion I have come to believe true” yet also claims that the post is “a result of intensive investigation of Milton “Skip” Ohlsen.”
45. In perpetuating the false claims while claiming factual conclusions as opinion, Defendant McElligott is acting with reckless disregard about whether his statements are true, and is thus acting with malice.
46. Mr. Ohlsen has suffered loss of business contracts and new business opportunities, and harm to his personal and professional reputation. This damages total Two Hundred Fifty Thousand and 00/100 Dollars (\$250,000.00). Defendant McElligott further acted with malice, and such actions warrant punitive damages in the amount of One Million Dollars (\$1,000,000.00).

WHEREFORE, Mr. Ohlsen prays for judgment against Defendant McElligott for the full amount of his aforementioned damages, the aforementioned punitive damages, for his attorney's fees, costs and for such other and further relief as this Court deems just and proper.

COUNT IV – CIVIL CONSPIRACY

(as to all Defendants)

47. Plaintiff re-alleges and incorporates herein by reference Paragraphs 1 through 47 as though fully set forth herein.
48. In Defendant McElligott's January 14 MySpace forum post, he states that he was "contacted by several people" who "saw the same picture" that he claimed he did.
49. On or about January 14, 2008, "Kracker" emailed a link of Defendant Hollenbeck's website to eight individuals or entities, including Peter McElligott, several of Genesis MMA's competitors and business associates, and Chad Garrison, a reporter for the Riverfront Times newspaper. Such email is attached hereto as Exhibit 6 and incorporated herein by reference.
50. Defendant McElligott's January 14 post claims that "it is apparent that there will be a story published in a local newspaper about Skip / AKA / Milton H. Ohlsen in the very near future [sic]".
51. ~~Chad Garrison published a story in the January 23, 2008 edition of the Riverfront Times repeating many of Defendant McElligott's and Defendant Hollenbeck's assertions.~~
52. ~~As of February 5, 2008, only two posts follow in the comments section following the online version of Mr. Garrison's story. One post is signed Joel Hollenbeck. The other is signed P.M. A copy of the online version of Mr. Garrison's story is attached as Exhibit 7 and incorporated herein by reference.~~
53. Subsequent to Mr. Garrison's story being published, Defendant Hollenbeck added a link to the online version of the story on his website.
54. Defendant McElligott's January 20 Myspace forum posting also references the story, exhorting readers to "pick up a copy of the River Front Times 1-23-08."
55. Defendant McElligott, posting under the name "Kracker" on the local Fox television message boards, linked Mr. Garrison's story, and claimed that previous posts on the subject were deleted, violating his "first amendment" rights. He notes that this story is

important to him personally, as it was his “kid brother who got burned.” A copy of the posting and subsequent comments is attached as Exhibit 8 and incorporated herein by reference.

56. On or about January 20, 2008, Mr. Ohlsen received a series of 19 unsolicited text messages from an anonymous source. The messages are attached as Exhibit 9 and incorporated herein by reference.
57. In addition to making threats against Mr. Ohlsen's life, the texts contain references to Kracker's October and January posts.
58. Throughout the texts, the anonymous sender makes reference to “we”, claiming that “we got u [sic],” and “we will stop when you have lost everything and u r dead [sic]”
59. The anonymous sender also shows advance knowledge of Mr. Garrison's story, declaring “[a]fter our story hits the paper next week u r over [sic].”
60. In order to bolster and validate their libelous publications, Defendant Hollenbeck and Defendant McElligott together agreed to contact Mr. Garrison and subsequently emailed Mr. Garrison to induce him to write a story, and then proceeded to taunt Mr. Ohlsen with these acts, and threaten his life and well-being.
61. Due to these posts, threats and false allegations, Mr. Ohlsen has suffered loss of business contracts and new business opportunities, and harm to his personal and professional reputation.

WHEREFORE, Mr. Ohlsen prays for judgment against Defendants Hollenbeck and McElligott, jointly and severally, for damages in excess of \$25,000.00, ~~to be proved at trial,~~ punitive damages in the amount of \$1,000,000.00, for his attorney's fees, costs and for such other and further relief as this Court deems just and proper.

COUNT V – TORTIOUS INTERFERENCE WITH A BUSINESS RELATIONSHIP

(as to all Defendants)

62. Plaintiff re-alleges and incorporates herein by reference Paragraphs 1 through 62 as though fully set forth herein.
63. Mr. Ohlsen had established contracts with Family Arena to host mixed martial arts events, and had a reasonable expectation that said agreements would be fulfilled.

64. Defendants Hollenbeck and McElligott published libelous and defamatory statements on websites and message boards.
65. Defendant McElligott contacted Mr. Garrison, a newspaper reporter, encouraging him to publish and perpetuate Defendants Hollenbeck's and McElligott's libelous and defamatory statements.
66. Family Arena, citing the allegations asserted by Defendants, and perpetuated by Mr. Garrison's article, ended their business arrangements with Mr. Ohlsen, and precluded any arrangements in the near future with Mr. Ohlsen.
67. Defendants Hollenbeck's and McElligott's actions were intentional, malicious, and designed to damage Mr. Ohlsen's business reputation.

WHEREFORE, Mr. Ohlsen prays for judgment against Defendants Hollenbeck and McElligott, jointly and severally, for damages in excess of \$25,000.00, to be proved at trial, punitive damages in the amount of \$1,000,000.00, for his attorney's fees; costs and for such other and further relief as this Court deems just and proper.

COUNT VI - INJURIOUS FALSEHOOD

(as to Defendant Hollenbeck)

68. Plaintiff re-alleges and incorporates herein by reference Paragraphs 1 through 68 as though fully set forth herein.
69. Defendant Hollenbeck's website was intended to harm Mr. Ohlsen's business and personal reputation, thereby injuring him financially.
70. Defendant Hollenbeck acted with actual malice towards Mr. Ohlsen by knowingly making false statements with knowledge that such statements were false, or with reckless disregard for whether or not the statements were true or false at a time when defendant had serious doubt as to whether they were true.
71. Defendant Hollenbeck published the allegations on his website with reckless disregard for the truth of the allegations, and is merely trying to attack Mr. Ohlsen for his relationship with Defendant Hollenbeck's ex-wife.
72. The published allegations did damage Mr. Ohlsen's personal and professional reputation, and caused him to lose contracts and business opportunities.

WHEREFORE, Mr. Ohlsen prays for judgment against Defendant Hollenbeck for damages in excess of \$25,000.00, to be proved at trial, punitive damages in the amount of \$1,000,000.00, for his attorney's fees, costs and for such other and further relief as this Court deems just and proper.

COUNT VII - INJURIOUS FALSEHOOD

(as to Defendant McElligott)

73. Plaintiff re-alleges and incorporates herein by reference Paragraphs 1 through 73 as though fully set forth herein.
74. Defendant McElligott's message board posts and January 14, 2008 email to Mr. Garrison were intended to harm Mr. Ohlsen's business and personal reputation, thereby injuring him financially.
75. Defendant McElligott acted maliciously towards Mr. Ohlsen to exact ~~revenge over what~~ he felt was Mr. Ohlsen's maltreatment of his brother.
76. Defendant McElligott acted with actual malice towards Mr. Ohlsen by knowingly making false statements with knowledge that such statements were false, or with reckless disregard for whether or not the statements were true or false at a time when defendant ~~had serious doubt as to whether they were true.~~
77. Defendant McElligott published the allegations on the message boards and emails with ~~reckless disregard for the truth of the allegations,~~ and was merely trying to attack Mr. Ohlsen to avenge perceived maltreatment of his brother.
78. The published allegations did damage Mr. Ohlsen's personal and professional reputation, and caused him to lose contracts and business opportunities.

WHEREFORE, Mr. Ohlsen prays for judgment against Defendant McElligott for damages in excess of \$25,000.00, to be proved at trial, punitive damages in the amount of \$1,000,000.00, for his attorney's fees, costs and for such other and further relief as this Court deems just and proper.

**COUNT VIII - Temporary Restraining Order,
Preliminary Injunction and Permanent Injunction
(as to Defendant Hollenbeck)**

79. Plaintiff hereby incorporates by reference Paragraphs 1 through 79 as if fully set forth herein.
80. The website operated and maintained by Defendant Hollenbeck is the direct cause of loss of business contracts and new business opportunities for Mr. Ohlsen, and has harmed and currently is harming his personal and professional reputation.
81. Mr. Ohlsen has no adequate remedy at law to prevent Defendant Hollenbeck's continuing wrongful conduct as described above. Specifically, the conduct of Defendant Hollenbeck in perpetuating the falsehoods on his website has caused irreparable harm and damage and will continue to cause irreparable harm and damage to Mr. Ohlsen by further loss of business contract and new business opportunities, loss of existing business contact and existing business opportunities, **harm to his professional and personal reputation** and loss of profits which are irreparable and continuing.

WHEREFORE, Plaintiff prays that this court enter the following orders and relief:

- A. That the court enter a temporary restraining order prohibiting Defendant Hollenbeck from publishing the aforementioned website including any and all links from the referenced website to any other affiliated website or third-party website or publication.
- B. That after hearing, this court enter a preliminary injunction prohibiting Defendant Hollenbeck, whether acting individually, indirectly or in concert with others from establishing or publishing any website concerning, relating to or in any other way referencing Plaintiff either directly or indirectly.
- C. That this court after trial issue a permanent injunction prohibiting Defendant Hollenbeck, whether acting individually, indirectly or in concert with others from establishing or publishing any website or any other publication, electronic or otherwise, concerning, relating to or in any other way referencing Plaintiff either directly or indirectly.

- D. That the court award Plaintiff its court costs, and such other and further relief as the court deems just and proper and equitable.

**COUNT IX - Temporary Restraining Order,
Preliminary Injunction and Permanent Injunction
(as to Defendant McElligott)**


82. Plaintiff hereby incorporates by reference Paragraphs 1 through 82 as if fully set forth herein.
83. The website and/or MySpace page operated and maintained by Defendant McElligott is the direct cause of loss of business contracts and new business opportunities for Mr. Ohlsen, and has harmed and currently is harming his personal and professional reputation.
84. Mr. Ohlsen has no adequate remedy at law to prevent Defendant McElligott's continuing wrongful conduct as described above. Specifically, the conduct of Defendant McElligott in perpetuating the falsehoods on his website/MySpace page has caused irreparable harm and damage and will continue to cause irreparable harm and damage to Mr. Ohlsen by further loss of business contract and new business opportunities, loss of existing business contact and existing business opportunities, harm to his professional and personal reputation and loss of profits which are irreparable and continuing.

WHEREFORE, Plaintiff prays that this court enter the following orders and relief:

- A. That the court enter a temporary restraining order prohibiting Defendant McElligott from publishing the aforementioned website including any and all links from the referenced website to any other affiliated website or third-party website or publication.
- B. That after hearing, this court enter a preliminary injunction prohibiting Defendant McElligott, whether acting individually, indirectly or in concert with others from establishing or publishing any website or any other publication, electronic or otherwise concerning, relating to or in any other way referencing Plaintiff either directly or indirectly.

- C. That this court after trial issue a permanent injunction prohibiting Defendant McElligott, whether acting individually, indirectly or in concert with others from establishing or publishing any website concerning, relating to or in any other way referencing Plaintiff either directly or indirectly.
- D. That the court award Plaintiff its court costs, and such other and further relief as the court deems just and proper and equitable.



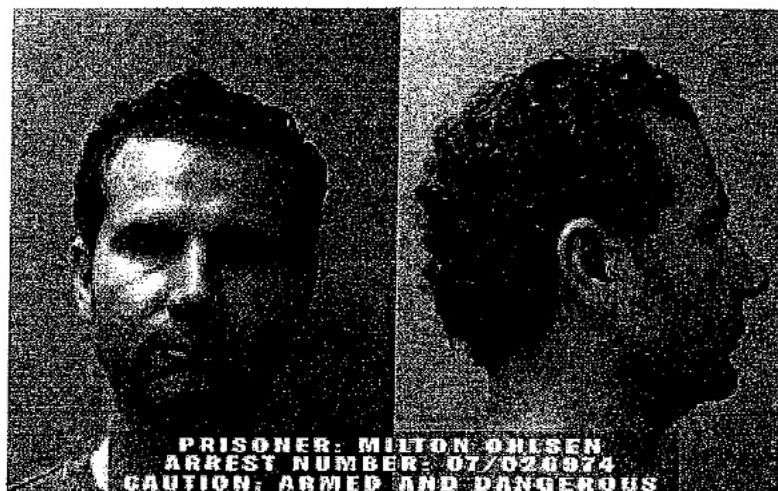

Who is Milton Ohlsen a.k.a. Skip Ohlsen ?

In the 1990's Skip was indicted on four federal counts of Selling, Dispensing or Distributing Narcotics and a Fraud charge. A significant amount of drug money in his possession was confiscated and forfeited. He is now a federally convicted felon for dealing drugs.

Sometime after this he started his own business doing a variety of things such as campaign consulting and even Mixed Martial Arts (MMA) fight promotions. Skip's MMA organization is known as Genesis MMA. Genesis Investors, employees and vendors were all burnt by Skip in the end. Leaving a trail of destruction including bounced payroll checks, unpaid bills and \$140,000 in investments vanishing.

Milton Ohlsen was married in 2000 and now has two children - one girl and one boy. He also has a girlfriend. While Genesis was falling apart Skip was busy blowing through cash lavishly living in hotels and enjoying the night life with his girlfriend. This pattern of behavior left his wife and children with nothing more than a mountain of debt.

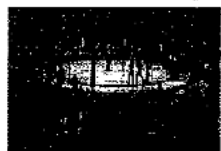

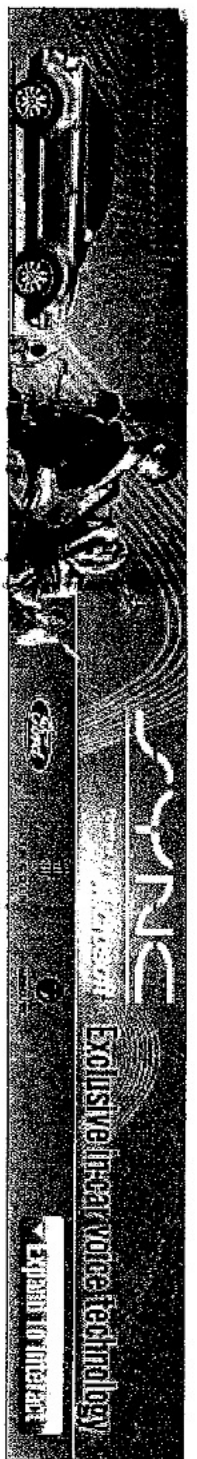

Phantom Punch

Milton "Skip" Ohlsen had big plans for mixed martial arts in St. Louis. Now it seems he's down for the count.

Milton "Skip" Ohlsen dreamed of being the Don King of ultimate fighting in St. Louis. In 2006 the then-34-year-old promoter formed the company Genesis MMA (mixed martial arts) and set up a steel-caged ring inside the St. Charles Family Arena. While other promoters hosted events in out-of-the-way union halls and hotel conference rooms, Ohlsen boasted that his fight drew more than 5,000 fans.

The next bouts — in March and June of last year — promised to be even bigger. Targeting the coveted 18- to 34-year-old demographic, Ohlsen aired commercials on alternative-rock station KPNT (105.7 FM) *The Point*, and ran television spots during *Late Night with Conan O'Brien*. Soon FOX Sports Midwest signed on to broadcast Ohlsen's matches, and the promoter claimed to be in negotiations for a reality show about mixed martial arts.

"It was exciting times," recalls Genesis MMA's director of public and media relations Dave Benson. "I think we had the potential to be substantial. We were creating a real buzz."

Like the first fight, Ohlsen's events in March and June drew thousands of fans, paying \$15 to \$150 to witness amateur fighters bloody themselves inside the steel ring. A fourth fight at the Family Arena was planned to take place in late September but was canceled the month before.

In October 2007 a new state law went into effect allowing paid professionals to compete in ultimate fighting. Ohlsen scheduled a November match at the Family Arena that promised to be the first large-scale professional mixed martial arts event in Missouri. But again Ohlsen canceled the fight with little warning.

Earlier this month Ohlsen called off his third straight fight at the Family Arena. The January 5 bout was to feature Brad "Hillbilly Heartthrob" Imes, a six-foot-seven-inch Missouri brawler and regular on the televised combat league, Ultimate Fighting Championship.

Mark Reifsteck, booking director for the Family Arena, downplays any concerns about Ohlsen's cancellations. "As I understand it, Skip just couldn't get the fighters together in time for January 5," explains an optimistic Reifsteck. "I'm sure he will bring another fight here soon."

Others aren't as convinced. In the wake of the latest canceled fight, former employees, vendors and investors now wonder what became of Skip Ohlsen and the thousands of dollars they claim he owes them. (Ohlsen did not return repeated calls for this story.)

Before becoming a fight promoter, Ohlsen ran the firms Global Management Solutions and Studio O Productions that specialized in assisting Democratic candidates in political races throughout Missouri. Ohlsen's most successful campaign may have come in 2006 when he helped strip-club operator Mike Ocello get elected to the Mehlville School Board. It was then that Ohlsen was first introduced to the sport of ultimate fighting.

"Ocello and some of his employees were really into martial arts," recalls Peter McElligott, a former employee of Ohlsen with Global Management Solutions and later Genesis MMA. "I think Skip went to a couple shows during that time and decided he could make a lot of money promoting the sport."

In December 2006 Ohlsen booked his first fight at the Family Arena and offered investors a piece of the action. All told, a group of at least four investors would sink as much as \$140,000 into Genesis, according to financial backers who asked not to be identified. "I just don't want my name associated with the guy," says one investor. "He damaged me financially. I don't want him to damage my name, too."

Another investor says he's considering a lawsuit against Ohlsen but worries there may not be any money to recover his losses. Another problem, he says, is he lacks evidence of his investments in Ohlsen's company. "From day one I asked him to get me documentation and paperwork showing my ownership in the business," says the investor. "He was always saying that the lawyers were working on them."

Peter McElligott severed ties with Ohlsen last June after working for him for three years on both his political campaigns and Genesis MMA. McElligott maintains Ohlsen never paid him for his last month of work and still owes him \$1,600. Now McElligott says he's come to discover that the state has no record of the income tax Ohlsen withheld from his

paychecks. "I'm waiting to see if I get a W-2 (tax form) from him," says McElligot. "Then I'm going to file a complaint with the Department of Revenue."

Last July the Fenton-based graphics firm Vinyl Images and Designs filed suit against Ohlsen after the promoter failed to pay for work the company did on his steel-cage ring. "He wanted it to look like a ring of fire," recalls Vinyl Images owner John Duever. "It was a last-minute job and took seven guys to install the image on the ring floor. He owes us \$11,000 and won't respond to phone calls or certified letters," alleges Duever.

Following the second canceled fight, Dave Benson, Genesis MMA's director of public and media relations, sensed the business was in a tailspin. Still, he tried to remain optimistic. "We weren't making money, but there was the sense we were on our way," remembers Benson. "But Skip had been drifting further and further away from the business."

Last month Benson says both his paychecks from Ohlsen bounced, leaving him out \$1,000 in wages. Benson also discovered that Ohlsen's private life had taken an unpleasant detour, with his wife filing an order of protection following an incident at their Town & Country home. In a court statement dated December 10, 2007, Michelle Ohlsen alleges her husband "physically restrained and choked me.... the choking was to where I could not breathe and [my] vision was starting to grey."

Subsequent divorce filings show the couple carries credit-card debt of more than \$82,000. The filing also listed Ohlsen's current place of residence as the downtown Westin. Last week a receptionist at the hotel said none of its guests were registered under the name "Ohlsen."

Earlier this month an anonymous author created a Web site dedicated to exposing other charges filed against Ohlsen, including federal drug-trafficking charges dating back to 1995. Moreover, it appears Ohlsen never bothered registering his Genesis MMA with the office of the Missouri Secretary of State, choosing instead to operate the company through his political consulting firm Global Management Solutions.

Tim Lueckenhoff, the administrator for the Missouri Athletic Commission, says he's familiar with Genesis MMA, but says his office has no record of Ohlsen applying for a license for the November and January fights, which never took place. "I'm surprised someone didn't call me," says Lueckenhoff. "At this point, there shouldn't be any confusion that you have to have a license for any professional MMA fight."

Meanwhile, Benson and others once associated with Ohlsen are wondering what other surprises may be in store. "I got to say I was blind-sided by all this," says Benson. "It's gotten to the point where I'm just going to pretend that my year spent working with Skip never happened."
